NEW SURVEY FINDS MAJORITY OF ADULTS WANT SUICIDE PREVENTION TO BE A NATIONAL PRIORITY AS A RESULT OF COVID-19

In September, the National Action Alliance for Suicide Prevention (Action Alliance)—in partnership with the American Foundation for Suicide Prevention, Education Development Center, and Suicide Prevention Resource Center—released findings from a national survey conducted by the Harris Poll to better understand the general public's perceptions on mental health, suicide, and suicide prevention. According to the survey of over 2,000 U.S. adults ages 18 and older, as a result of the pandemic:

- Majority of adults surveyed (81%) want suicide prevention to be a national priority
- Over half of Americans (52%) report being more open to talking about mental health

The survey, which builds upon previous surveys in 2015 and 2018, speaks to the need for urgent action around these critical public health issues, in the wake of the pandemic, and that Americans do want to take action to prevent suicide. In fact, most Americans believe suicide can be prevented (93%) and would do something if someone close to them was thinking about suicide (95%).

BILL TO MAKE 988 THE NATIONWIDE SUICIDE PREVENTION HOTLINE HEADS TO THE PRESIDENT'S DESK

Legislation designating the three-digit code 988 as the universal, hard-to-forget phone number people in the U.S. can dial to reach the National Suicide Prevention Lifeline is moving to the president's desk for signature.

The House of Representatives on Monday passed the National Suicide Hotline Designation Act, which the Senate passed in May. The bill builds on a many months-long effort that involves the Federal Communications Commission—and ultimately aims to help save lives by making it easier for individuals to remember how to access mental health support they need.

For now, people hoping for help are encouraged to continue to use the 10-digit number to connect to the hotline—1-800-273-8255—until the agency finalizes the technical implementation of the nationwide three-button number.

CENTERSTONE RECEIVES SUICIDE PREVENTION GRANT

As the year 2020 progresses, the COVID-19 pandemic continues to impact our community. The worries, fears and uncertainties that society is experiencing during these historic times are profound. In the midst of this widespread crisis, increasing levels of behavioral and psychological distress have been recognized. As a result, many individuals, especially those with pre-existing mental health conditions, are considered to be at a greater risk for suicide. COVID-19 related anxiety and stress combined with stay-at-home quarantine orders, rising unemployment rates, financial hardships and

increasing domestic violence are negatively impacting mental health.

In effort to provide crucial support to those who are struggling, SAMHSA has awarded *Centerstone* grant funding to respond to these very needs within the community. The COVID-19 Emergency Response for Suicide Prevention Grant will allow *Centerstone* to provide enhanced suicide prevention services to adults residing in Manatee and Sarasota counties, placing a special emphasis on supporting victims of domestic violence. The Suicide Prevention Program staff will provide rapid follow-up care and deliver services in a combination of settings, including telehealth/virtual options. The support that we offer is tailored to meet the individualized needs of each person and family. Services provided by *Centerstone's* team include care transition and coordination, risk assessment and screening, crisis management planning, evidence-based practices, recovery support services, crisis intervention, education (related to mental health, suicide prevention and domestic violence), family support, therapy (individual and family), peer support and advocacy, counseling on access to lethal means and referrals to appropriate community resources.

In addition to serving individuals and families, *Centerstone's Suicide Prevention Program* will offer evidence-based trainings for community members and agencies, providing participants with tools and resources to improve their competence and confidence in assessment of suicide risk and protective factors. These trainings will also address best practice interventions to maintain safety and follow-up measures to ensure continuity of care.

Through the Suicide Prevention Program, *Centerstone* will instill hope and spread the word that depression is common and treatable. Suicide is preventable; one is too many. This program will undoubtedly contribute to the continued promotion of these empowering and important messages. Those who struggle are not alone; help is a phone call away.

Preventing suicide in any school setting requires a comprehensive approach. This framework can be adapted to the needs of an individual school and its COVID-19 learning approach, whether in-person, remote, or hybrid. Key principles that all schools should consider are a commitment to promoting emotional well-being and connectedness among students, as well as identifying those who may be at risk for suicide and connecting them to help. In thinking about how to tailor these principles for each school community and its students, we must acknowledge that the pandemic has also brought persistent racism and racial and ethnic disparities into focus. Individual and community needs, and their inequitable distribution, are essential factors to keep in mind when designing and implementing suicide prevention strategies, services, and supports in schools.


